

## **Keynote Speakers**



Professor Antoinette Schoar is the Stewart C. Myers-Horn Family Professor of Finance, MIT Sloan School of Management. She holds a PhD in Economics from the University of Chicago and an undergraduate degree from Germany. Her research interests span from entrepreneurial finance to fintech, consumer finance, and financial intermediation. She has received several awards including the Kauffman Prize Medal for Distinguished Research in Entrepreneurship and the Brattle Prize for best paper in The Journal of Finance. She is the co-chair of the NBER Corporate Finance group. Professor Schoar is the EiC of *The Journal of Finance*, and she has served as an associate editor of *The American Economic Journal: Applied Economics*, and the Journal of Economic Perspectives. Prof. Schoar will join the event virtually in a hybrid session, where both face-to-face and online

audiences will have opportunities to ask questions.



Sofia Johan is Associate Professor of Finance at Florida Atlantic University, USA. She is also affiliated with InnoLab, University of Vaasa and the Tilburg Law and Economics Center (TILEC). She holds a PhD from Tilburg University in the Netherlands and also law degrees from University of Warwick and University of Liverpool in the United Kingdom. She has served as the Academy of Management Entrepreneurship Division's Representative at Large since 2021 and is Chair of the Global Scholars Development Committee. She is Co-Editor of Venture Capital: An International Journal of Entrepreneurial Finance and an Associate Editor of the British Journal of Management, British Accounting Review and International Journal of Finance and Economics. Her research is focused on alternative finance (including but not limited to

crowdfunding, peer to peer lending and cryptocurrencies) and alternative investments (including but not limited to hedge funds, venture capital, private equity, real estate investment trusts and IPOs). Her research has been published in the Entrepreneurship Theory and Practice, American Law and Economics Review, Journal of Financial Economics, Academy of Management Journal, Journal of Quantitative Analysis, Journal of Banking and Finance, European Financial Management, and European Economic Review, among other journals. Prof. Johan will join the event in person and deliver a talk in a hybrid session, where both face-to-face and online audiences will have opportunities to ask questions.

#### **The Financial Review**

The Conference Organising Committee will choose selected papers from those presented at the conference to be considered for publication at The Financial Review (FR). Within two months of the conference date, these papers will go through a blind review process. This is a "no-fault" submission option, which means that if the FR decides to review the paper and rejects it, the author(s) can submit the paper to the FR through the normal submission process. Papers submitted must not be under review at any journals.
